Clint Giberson moved to approve adding the 2nd Assistant Fire Chief to the Budget at a Yearly Salary of \$6,000 per year. seconded by John Pealsey. Motion passed. (7) Ayes (0) Nays (1) Abstained – (Shelly Ready)

Chair Phillips asked the members for questions or comments on the proposed Budget. Hearing none, he entertained a Motion to accept as presented the proposed Yamhill Fire Protection District Budget for the 2022/2023 budget year.

Paul Van De Grift moved to approve the Yamhill Fire Protection District Budget of 2022-2023, as presented by the Budget Officer, and levy the permanent rate of .9081 per thousand dollars of assessed value for operation purposes and the Local Option Capital Levy of .55 per thousand dollars of assessed value for Capital projects. Approved are the 2022-2023 General Fund budgets in the amount of \$1,308,466.00, and the
