1. The District ran a total of 35 calls for the month of September 2018.

- 2. Projects currently working on;
 - a. SOG's & SOP's This is an ongoing project.
 - b. ISO rating Continue to work on this project October 2018.
 - c. District Policy, Procedure and SOG Manual Work in progress
 - d. Jason Armstrong Annex into District State Paperwork
- 3. The paperwork for the Garner Complex, Taylor Creek and Sugar Pine conflagration fires has been filed. Brush 4 generated about \$30,000 to the District. These funds will go to purchase, Turnouts, Helmets, Portable Radios and Extrication Equipment.
- 4. Flying M Sub-Station The Rock has all been finish and construction will start Sunday October 7, 2018.
- 5. The Seismic Retrofit is moving along. The siding metal is here, and they are starting to install. Also finishing up all the little odds and ends. They have been having issues with Taylor who is providing the siding metal. The first metal for the front of the building was cut 6" to short. This was a mess-up on Taylor's part. They sent new metal and they found when they started putting it up that there is a ¼" inch in wide between the Top and bottom of each sheet. Taylor is now re-making the front metal for the 3rd time. This is all at Taylor's expense.
- 6. The New Command Vehicle is here. The Canopy and Tank has been installed, the Lights and Radios will be done around the middle to end of October.
- 7. The Volunteers continue to work on Training from EMS, Wildland, Instructor, and Firefighter. We have 3 volunteers that have started the EMT class.
- 8. Do to issues with the Water system at the school, I have been working with the District's Legal Counsel. See attached response (Fire Board Information Only!) to the School and City from Carrie. (Will be in your Book on Monday still work in progress)

- 9. We purchased 3 sets of Demo Turnouts (2 years old) for \$880 each. New ones are approx. \$2500 each.
- 10. Trampas and I will be attending a NFPA 3000 class at DPSST in Salem on Tuesday morning to learn about the new Active Shooter Guidelines. I will also be out of District this Friday thru Sunday for a short 3-day weekend. Trampas will be covering as the Duty Officer.
