- 2. Projects currently
 - a. ISO rating We have submitted the last of the paperwork to ISO. Just waiting for the response.
 - b. We have finalized the build for the new Brush Rig. Still on schedule for a June 2021 completion date. Finalized the funding piece and have ordered the radios.
 - c. We are currently working with the vendor to get the correct 4" hose.

3. Grants

- a. AFG SCBA's The new SCBA's are here, and were placed in service on January 21, 2021
- b. Safer Act The 7th request has been submitted.
- c. I re-submitted an AFG-S grant last week for just over \$37,000 for supplies used for the COVID-19 event. We were not awarded.
- d. The new AFG application period has opened. Working on that application with the plan of applying for, 22 sets of Turnouts, 22 additional SCBA face masks, 9 Triband mobile radios and 20 pagers. This has been submitted.
- e. We did receive a 50/50 matching grant from SDAO for Security to purchase more camera's to be installed in the building next door. Working on.
- f. Will be working with Murray Paolo on the Homeland Security Grant for Radios.
- g. Looking at other Grants as they become available.
- 4. We are still waiting on reimbursement from the State for the Conflagration Fires in the amount of about \$130,000.000.
- 5. On Thursday 2-4-2021 I was notified by ODF of a Type 3 Brush rig that was available thru the FEPP program. I have talked with them some and have put are name in as a possible candidate for this rig. This went to another agency; we were number 2 for this rig.
